**Pernyataan Komnas HAM Terkait Gugatan Afrika Selatan Terhadap Israel Atas Dugaan Genosida di Gaza Palestina**

Komnas HAM menerima imbauan mendesak (*urgent appeal*) dari Komnas HAM Palestina melalui *Asia Pacific Forum for National Human Rights Institution* (APF) yang merupakan koalisi *National Human Rights Institution* (NHRI) di Asia Pasifik, untuk mendukung upaya hukum yang dilakukan oleh Afrika Selatan di *International Court of Justice* (ICJ) di Hague atas dugaan Genosida oleh Israel di Gaza Palestina.

Persidangan atas upaya hukum Afrika Selatan terhadap Israel yang diduga melakukan genosida di Gaza Palestina akan dimulai 11 Januari 2024.

Berdasarkan hal tersebut, Komnas HAM menyatakan hal-hal sebagai berikut:

1. Mendukung upaya hukum Afrika Selatan terhadap Israel di ICJ atas dugaan genosida di Gaza Palestina
2. Mendorong Pemerintah Indonesia untuk melakukan intervensi di ICJ dengan mendukung upaya hukum Afrika Selatan di ICJ atas dugaan genosida yang dilakukan oleh Israel di Gaza Palestina.

**Statement Regarding South Africa's Application to Initiate Proceedings Against Israel  
for Genocide in Gaza, Palestine**

The Indonesia National Human Rights Commission (Komnas HAM) has received an urgent call to action from the Palestine Independent Commission for Human Rights (ICHR) through the Asia Pacific Forum for National Human Rights Institutions (APF) a network of National Human Rights Institutions in the Asia Pacific Region to support the legal action taken by South Africa at the International Court of Justice (ICJ) in The Hague, Netherlands over alleged genocide by Israel in Gaza, Palestine. The proceeding at the ICJ will begin on 11 January 2024.

In the light of South Africa application instituting proceedings against Israel, Komnas HAM states the following:

1. Support South Africa's legal proceedings against Israel before the ICJ for alleged genocide in Gaza, Palestine
2. Encourage the Indonesian Government to intervene before the ICJ by supporting South Africa's legal proceedings before ICJ over the alleged genocide committed by Israel in Gaza, Palestine.
